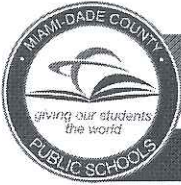
Senate Bill 1546 enacted by the 1997 Legislature requires school districts to report certain financial information in the form of a school financial report, to parents/guardians.


